#### ABBREVIATIONS/DEFINITIONS

#### Abbreviations/Definitions

- **Board of Fraternity Affairs (BFA)**: an organizational hearing body responsible for adjudicating fraternity cases
- Board of Sorority Affairs (BSA): an organizational hearing body responsible for adjudicating sorority
  cases
- **Disciplinary Officer (DO):** a staff member empowered to adjudicate student disciplinary cases that would not result in suspension or dismissal (and that do not include allegations of sexual misconduct)
- Office for Student Conflict Resolution (OSCR): the department responsible for overseeing the university's student discipline system
- Office of Registered Organizations (ORO): for purposes of this document, an organizational hearing body responsible for investigating and adjudicating allegations against organizations that are neither sororities nor fraternities
- Organizational Hearing Body (OHB): any body responsible for adjudicating registered student organization disciplinary cases
- **Residence Hall Judicial Commission (RHJC):** a disciplinary hearing board made up of student justices who live in the residence halls
- Senate Committee on Student Discipline (SCSD): the Senate committee responsible for establishing student disciplinary procedures, issuing sanctioning guidance to all hearing bodies, and deciding appeals of all subcommittee decisions
- Subcommittee on Graduate Student Conduct (SGSC): the subcommittee, composed of faculty and
  graduate students, responsible for deciding graduate student cases that could result in suspension or
  dismissal (and that do not include allegations of sexual misconduct)
- Subcommittee on Sexual Misconduct (SSM): the subcommittee, composed of faculty, staff, and students, responsible for deciding all student cases that include allegations of sexual misconduct
- Subcommittee on Undergraduate Student Conduct (SUSC): the subcommittee, composed of faculty and undergraduate students, responsible for deciding undergraduate student cases that could result in suspension or dismissal (and that do not include allegations of sexual misconduct)


