## Senate Committee on Student Discipline 2008-2009 Annual Report

The Senate Committee on Student Discipline (SCSD) met 11 times during the 2009 fiscal year and considered a total of 11 appeals from action of its Subcommittees including the Subcommittee on Undergraduate Student Conduct (SUSC). They also had a hearing to confirm a decision by the College of Engineering to dismiss a student for breach of academic integrity. Of the 11 appeals and one hearing, the SCSD affirmed 8, modified 3 and dismissed charges on one. The SCSD also had a special meeting to consider a Chancellor's interim suspension which was also affirmed.

#### Highlights of 2008-2009

- 1. SCSD Membership. A proposal was made by student members of the SCSD several years ago to increase the student membership on the committee from four to six members. This recommendation was tabled by the committee until after all procedures were reviewed and finalized. In the spring of 2008, the committee voted to recommend this increase in membership and this recommendation was sent to the chair of the University Statutes and Senate Procedures committee. This proposal was acted on in the spring of 2009 and the 2009-2010 committee will include six student members.
- 2. Subcommittee Selection. Since the new executive director was hired in 2007, a major focus of the SCSD has been to increase the number and diversity of the applicants to all disciplinary subcommittees, in particular the undergraduate subcommittee. In the spring of 2009, we saw our highest number of undergraduate applicants yet (31). Eleven (11) of these undergraduates were asked to serve in the coming year. In addition, the office also had a major push for the selection of new faculty members to the committee. An advertisement was placed in the e-week newsletter along with a number of other promotional efforts and four new faculty members were selected to serve. While turnover of the faculty has become somewhat more frequent in recent years, the addition of new faculty who are interested and committed to student development is a net win for our efforts.


- 3. Appeal Training. The SCSD is primarily responsible for addressing the appeals of dismissal decisions made by the lower hearing bodies. The committee has struggled to limit the review of discipline cases to the criteria for appeal and avoid the temptation to rehear a case without involving all of the original witnesses and alleged victims. OSCR worked with the Office of the University Counsel to provide a supplemental training for the membership to assist them in evaluating the appeal requests with a more limited lens in keeping with the intention of disciplinary procedures. While in its infancy, our hope is that this training will assist the committee in addressing appeals appropriately while also engendering greater trust within the process. The criteria for appeal are (i) the hearing was not conducted fairly in light of the charges against the respondent, (ii) the decision reached regarding the respondent was not based on substantial information, (iii) the sanction(s) imposed by the hearing body was/were not appropriate for the violation(s), and (iv) new information or other relevant facts clearly not available at the time of the original hearing because such facts are now available. Our appeal process is not intended for an appeal committee to substitute its judgment for that of the original committee.
- 4. Disciplinary Committee Chairperson Training. For many years, the chairperson of the Undergraduate subcommittee hearings was the same person every week for every hearing. As the caseload of the office increased and thus the number of hearings, and put a tremendous amount of pressure on one volunteer faculty member to continuously serve. Further, having a limited number of possible chairpersons became a logistical issue as hearing times were limited to when a trained chairperson could attend. Thus, in the spring of 2009, all faculty members serving on subcommittees were trained to be chairpersons of hearings. A standardized hearing outline is followed for each hearing and chairpersons are trained about how to address procedural problems and develop a decision from the committee. This has resulted in greater flexibility in scheduling, better reliance on sanctioning guidance and stewardship of the process, and shared ownership of the discipline process by all members.
- 5. Disciplinary Committee Appreciation. Subcommittee members volunteer their time and effort in ways that far exceed what most Student Affairs offices ask of their volunteers. Hearings often go on until late in the evening and involve highly emotional and intensely personal issues of substance addiction, domestic violence, and sexual assault. That kind of commitment deserves and demands the respect of the entire campus community. In the spring of 2009, OSCR hosted an appreciation ceremony for all members of these subcommittees as an expression of our gratitude. The appreciation also coincided with the spring training of all new members of the committee who stayed to meet returning members. Of note was the special recognition for Dr. Carl Nelson, who elected to step down as primary chairperson after 13 years of service. Many of the students who graduated this spring had served the committee for three years and the level of their service to the University was truly magnanimous.
- 6. Publicity and outreach. At the direction of the SCSD, OSCR has made significant investments in publicity materials this fiscal year to better educate the campus community about office services. A new professional brochure reflective of new campus identity standards was developed early this summer. In addition, the office invested in a table skirt and display board which more professionally represents the office at resource fairs and campus events. Finally, the office purchased promotional pens with the name of the office and contact information. We hope that this attention to publicity will increase the visibility of our office and services as well as encourage students and organizations to contact us for educational seminars and discussions about community standards, alternative dispute resolution, and the Tolerance Program. Changes to the OSCR webpage have been postponed to coincide with the current revision of all web pages in Student Affairs this academic year.
- 7. **Graduate College Proposal.** The SCSD considered a proposal from the Graduate College regarding the conduct of graduate students. The proposal reflected the view that standards of

conduct regarding behavioral violations of the <u>Student Code</u> are higher for graduate students because of their relative age, position, and responsibility within the University community. The SCSD expressed support for the sentiment, but requested that the Graduate College seek the input of students before implementation of this change.

8. **Digital Recorder.** All subcommittee disciplinary hearings in the spring of 2009 were digitally recorded eliminating the needs for audio tapes and providing greater flexibility for appeal committees to locate relevant testimony at issue in appeals. The quality of these recordings has improved dramatically as staff members have become more familiar with the equipment and microphone placement has been perfected.
