Also in FY22, trained decision-makers under the authority of the Senate Committee on Student Discipline addressed 91 cases in which students had been found responsible for a second, third, etc. academic integrity infraction. As a result, 2 students were issued censures, 81 students were placed on conduct probation, 2 students were placed on dismissal held in abeyance status, and 6 were dismissed from the university.
